Reports from Committees:

* Commander Kolb informed the camp of his intention to mark all of the graves of the Last Union Soldiers that reside in the donut counties surrounding Marion County. He discussed the possibility of having a brass medallion made for the purpose of marking these graves. These medallions could be attached to the stone with epoxy.

Possible wording on the medallions was discussed. It was agreed that the wording should be the "Last Union Veteran Buried in this County" on the top with the dates "1861-1865" on the bottom. Commander Kolb will secure a quote and report back at the February 2023 camp meeting.

- * Camp Baseball Cap Committee: The committee reported that the camp still has 27 caps in inventory.
- * Cemetery Cleaning and Restoration Committee: Mike Beck reminded the camp of the upcoming Wreaths Across American ceremony that will take place on December 17th at the Williams Creek Cemetery. Garry Walls informed the camp that he has not received any response from the cemetery officials of Little Eagle Creek Cemetery, so we will probably not be working in that cemetery next May. Brother Beck will start looking at possible cemeteries to work in for the camp annual cemetery workday in May, 2023.
- * Civil War Memorial Monument and Oversight Committee: No update
- * Community Public Relations Committee: No update
- * Sultana Monument Committee: Commander Kolb updated the camp about the Sultana Monument. The plaque was ordered and the Department of Indiana has cut the check to the vendor. Estimated time for installation of the plaque onto the stone is spring of 2023 (when the weather warms up enough). The camp still has money in the treasury earmarked for this monument. Other possibilities for this monument included having a time capsule installed at the site, as well as having memorial bricks for sale to place around the monument.
